

# Keynote Speakers



Alexis Garcia is 19 years old and attends Arizona State University in hopes to graduate in the next year with a bachelor's in Psychology. He is a senior organizer at both Arizona Center for Empowerment- ACE and Living United for Change in Arizona- LUCHA.

He has been involved in the movement for over 3 years now! He started off as a sophomore in high school and is now going into his sophomore year at university!

He does this work primarily because of his parents, who immigrated from Mexico in 1995. They came to the U.S. not only hoping for a better life but also for bigger and better opportunities for their future children.

In the current political climate, there is a negative connotation on people of color and in particular undocumented folks. He is tired of seeing people like his parents, and students of color like his sisters continued to be oppressed for their gender, skin color, or status.

He continues to organize and share his story to bring more people into this fight, because he knows he can't do this alone and how we get to our communal liberation is together.

# Keynote Speakers



Ylenia Aguilar was born in Orizaba, Veracruz, Mexico and currently serves as a Governing Board President in the Osborn School district, #8 in Phoenix, Arizona. She was undocumented and became a Naturalized U.S. Citizen in 2014. She voted for the first time in a presidential election and for herself on November 8, 2016.

Ylenia was highly active at both of her son's schools, and was asked to participate in committees at a district level. The more she learned about school governance, the more she was able to see that her influence would have widespread support of the community, particularly in the Latino community. The Osborn School District Governing Board in 2016 had zero representation of current parents and Ylenia knew that her obligation to support her children's education had to take a greater role. She ran for an open seat and won election to the Board, assuming the seat in January 2017. Ylenia served the first year as a Member, and since has been elected to leadership on the Board, first as Clerk in 2018, and two consecutive terms (currently serving) as Board President in 2019 and 2020.

Ylenia is an advocate for quality education and believes that diversifying the curriculum with multicultural education allows for all students to be validated in their education. In our diverse world, we need to validate all histories and all of humanity. "It is my opinion that culturally responsive curriculum gives the students more of an opportunity to become engaged academically. Education provides the opportunity to have more opportunities in life. For communities who have historically been marginalized, education can be the equalizer."





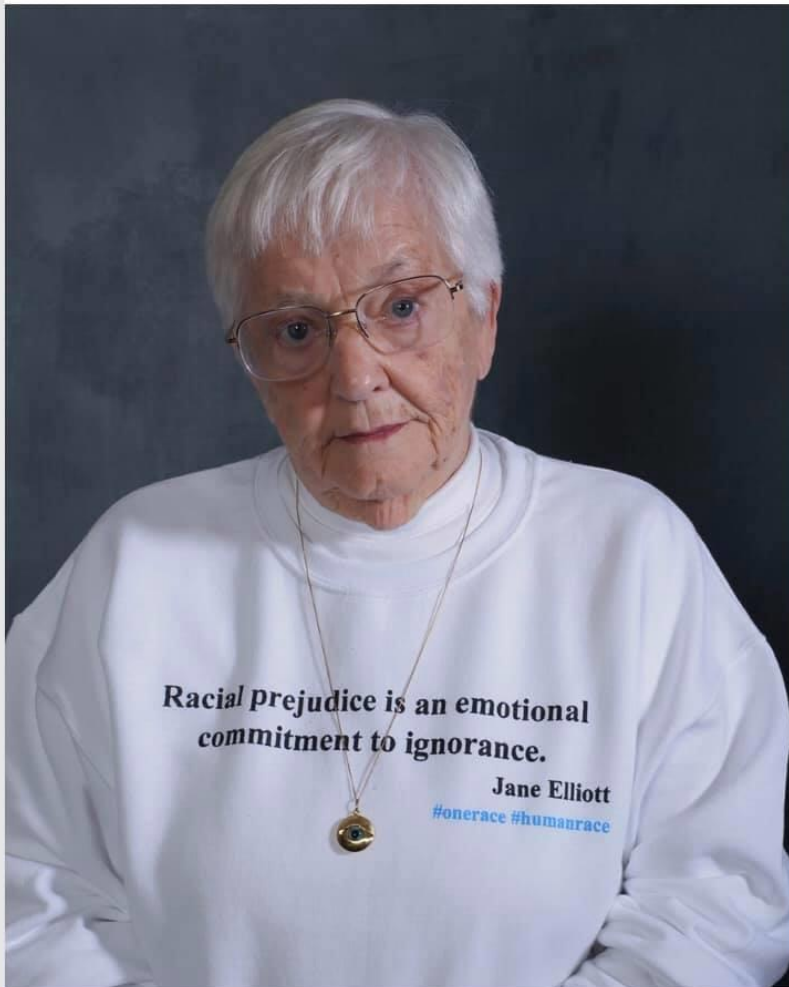
# Keynote Speakers

Dr. Jane Elliott, internationally known educator, lecturer, diversity trainer, and recipient of the National Mental Health Association Award for Excellence in Education, exposes prejudice and bigotry for what it is, an irrational class system based upon purely arbitrary factors.

In response to the assassination of Martin Luther King, Jr. in 1968, Jane Elliott devised the controversial and startling, "Blue Eyes/Brown Eyes Exercise." This, now famous, exercise labels participants as inferior or superior based solely upon the color of their eyes and exposes them to the experience of being a minority. Everyone who is exposed to Jane Elliott's work, be it through a lecture, workshop, or video, is dramatically affected by it. And if you think this does not apply to you. . . you are in for a rude awakening.

Dr. Elliott was awarded her first honorary doctorate from her alma mater, the University of Northern Iowa, in December of 2018 and her second from the California State University Bakersfield in June of 2019.

Blue Eyed audience viewer, Stuttgart Zeitung states; "It won't help much to be prepared to face Jane Elliott. This elderly woman will tear down any shield. Even we, the spectators in BLUE EYED, can't get rid of this feeling of uneasiness, embarrassment, anxiety and utterly helpless hatred when she starts keeping people down, humiliating them, deriding them, incapacitating them. No doubt about this: for three quarters of the time in this documentation Jane Elliott is the meanest, the lowest, the most detested, the most hypocritical human being hell has ever spit back on earth. But she should be an example for all of us."

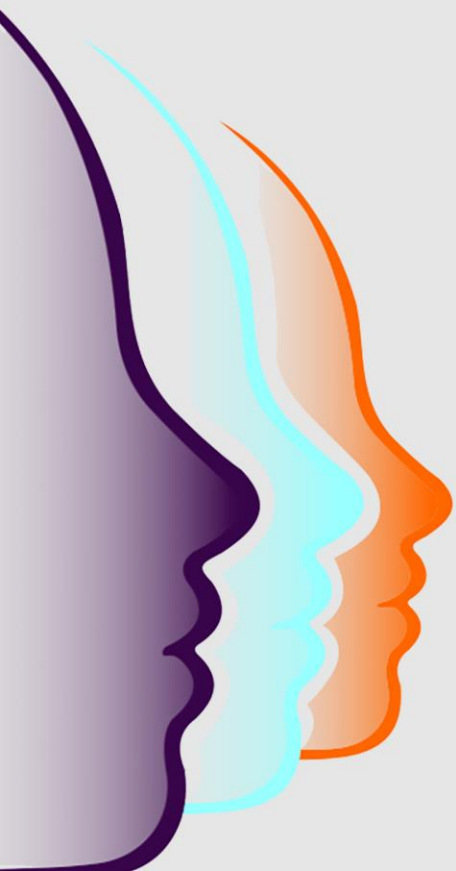


# Convention Rules

***The following Standing Rules have been adopted by the Board of Managers as an emergency action to enable Arizona PTA to conduct business by way of virtual meetings and are hereby included in the 2020 AZPTA Convention Rules:***

## Rules for Electronic Meeting via Internet Meeting Services

1. Login Information. An e-mail will be sent to every member of the particular group to be meeting (BOM, EC, Committee, Delegates, etc.), at least 24 hours before each meeting, the time of the meeting, the URL and codes necessary to connect to the Internet meeting service, and, as an alternative and backup to the audio connection included within the Internet service, the phone number and access code(s) the member needs to participate aurally by telephone. You shall also receive a copy of, or a link to, these rules. For committee meetings the committee chair shall facilitate the call to the meeting and provide the login information.
2. Sign in/Sign out. Members shall identify themselves as required to sign in to the Internet meeting service, and shall maintain Internet and audio access throughout the meeting whenever present, shall mute their microphone when not speaking and shall sign out upon any departure before adjournment.
3. Technical Requirements and Malfunctions. Each member is responsible for his or her audio and Internet connections; no action shall be invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented participation in the meeting.



# Convention Rules (continued)

4. Quorum. The presence of a quorum shall be established by audible/visual roll call at the beginning of the meeting. In the event of a virtual state convention, the presence of credentialed delegates verified at the time of login as provided the internet meeting service may be used to determine the presence of a quorum. Thereafter, the continued presence of a quorum shall be determined by the online list of participating members, unless any member demands a quorum count by audible roll call. Such a demand may be made following any vote for which the announced totals add to less than a quorum.

5. Forced Disconnections. The chair or facilitator may cause or direct the disconnection or muting of a member's connection if it is causing undue interference with the meeting. The chair's decision to do so, which is subject to an undebatable appeal that can be made by any member, shall be announced during the meeting and recorded in the minutes.

6. Assignment of the Floor. To seek recognition by the chair, a member shall signal the chair using the designated feature appropriate to the Internet meeting service being used. Upon assigning the floor to a member, the chair will signal the facilitator to clear the online queue of members who had been seeking recognition. To claim preference in recognition, another member who had been seeking recognition may promptly seek recognition again, and the chair shall recognize the member for the limited purpose of determining whether that member is entitled to preference in recognition.

7. Interrupting A Member. A member who intends to make a motion or a request that under the rules may interrupt a speaker shall use the designated feature for recognition and shall thereafter wait a reasonable time for the chair's instructions before attempting to interrupt the speaker by voice.

8. Motions Submitted In Writing. A member intending to make a main motion, to offer an amendment, or to propose instructions to a committee, shall, before or after being recognized, post the motion in writing to the online area designated by the Secretary or facilitator for this purpose, preceded by the member's name and a number corresponding to how many written motions the member has so far posted during the meeting (e.g. Mary M #1, Mary M #2).

# Convention Rules (continued)

9. Motions. The Secretary or meeting facilitator shall designate an online area exclusively for the display of the immediately pending question and other relevant pending questions (such as the main motion, or the pertinent part of the main motion, when an amendment to it is immediately pending); and, to the extent feasible, the Secretary, or any assistants appointed by him or her for this purpose, shall cause such questions, or any other documents that are currently before the meeting for action or information, to be displayed therein until disposed of.

10. Voting. Votes shall be taken by a virtual voting feature of the Internet meeting service, unless a different method is ordered by the Board or required by the rules. When required or ordered, other permissible methods of voting are by electronic roll call or by audible roll call. The chair's announcement of the voting result shall include the number of members voting on each side of the question and the number, if any, who explicitly respond to acknowledge their presence without casting a vote. Business may also be conducted by unanimous consent.

11. Video Display. [For groups using video, but in which the number of participants is too large for all to be displayed simultaneously:] The chair, Secretary, meeting Facilitator, or their assistants shall cause a video of the chair to be displayed throughout the meeting, and shall also cause display of the video of the member currently recognized to speak or report.

12. The Parliamentarian shall advise the presiding officer on points of procedure and on request of the presiding officer, shall explain such points to the delegates.

13. There will be an official timekeeper at all General Meetings.

# Convention Rules (continued)

14. All registered accredited voting delegates, registered alternates, any other PTA member registrants, Arizona PTA board members, volunteers, vendors/exhibitors, service providers are expected to be respectful of others. Harassment and other misconduct will not be tolerated. Arizona PTA, at its sole discretion, reserves the right to accept or decline an individual's registration for the Convention and General Meetings entry.

15. Arizona PTA reserves the right to prohibit entry or remove any individual whether registered or not, whether they are registered accredited voting delegates, registered alternates, or any other PTA member registrants, exhibitors, representatives, vendors who in Arizona PTA's sole opinion are not keeping with the character and purpose of the Convention including General Meetings.

16. Without limiting the aforementioned, Arizona PTA reserves the right to confiscate convention access, any other PTA member registrants access, remove to refuse Convention entry to any accredited voting delegate, alternate, any other PTA member registrant, exhibitor, representatives/vendors who has registered or gained access under false pretenses, provided false information, or for any other reason. whatsoever that they deem is caused under the circumstances. In such a case, if any registration/exhibitor or vendor space fees have been paid, no refunds will be given. No refund of delegate or exhibitor fees will be given in the case of a removal for such cause.

17. All electronic devices with the exception of the device being used to view the virtual Convention should be turned to silent, vibrating mode or off during all live General Meetings, presentations and workshops.

18. All children and/or students attending the convention must be supervised by a parent/guardian or a designated adult at all times.
